- Reviewing artworks to ensure they abide by DSP guidelines.
- Processing audio files and all other digital assets ensuring these are filed and archived.
- Overseeing and monitoring content deliveries, logging all successful deliveries and addressing any issues.
- Managing content issues and update requests from customers and DSPs - investigating, fixing, responding to and confirming fixes, liaising with internal and external contacts throughout.
- Processing DSP catalogue reports to generate links for customers and identify any issues with failed ingestions on DSPs side.
- Assisting with testing on changes to internal and external systems.
- Maintaining internal documentation and disseminating where appropriate.
- Maintaining good relationships with DSPs.
